Today we respond to roughly 9,000 calls per year, which covers the only refinery in the state of Colorado, major highways, large industrial, commercial and residential properties. This is a special place with traditional roots, heart, passion, and dedication that will always strive for what is best for our community and citizens.

Since 2015 SACFD has hired over 66 firefighters and counting, hired over 15 administrative support staff, replaced much needed fire apparatus, fire gear, and breathing apparatus, and in 2017 South Adams achieved an ISO Class 2 Fire Department! This was a huge accomplishment and an improvement from a rating of nearly a 6!




ABOUT SOUTH ADAMS COUNTY FIRE DEPARTMENT







Northglenn Ambulance, Inc. is a non-profit ambulance service providing 911 medical response to the South Adams County Fire Protection District.

Northglenn Ambulance is a Colorado non-profit ambulance service. We were founded in 1963 by the citizens of the area which would soon be incorporated as the City of Northglenn, a suburb of Denver. Although our company has grown over 750% during the last 4 decades the City of Northglenn remains the home to our headquarters.

OUR HISTORY

February 9, 1942: the South Adams County Fire Department was formed as an all-volunteer fire department.

1952: South Adams County Fire District was formed with a 1/2 mill tax levy. In 2013, thanks to the citizens' faith in 5A, SACFD became a combination department of reserve firefighters, and career staff.

1942: The volunteers responded to 69 fire calls with 10 volunteers; in 2018 the department responded to almost 9,000 calls with over 45 career firefighters and 25 volunteers.

1971: The South Adams County Fire Prevention Bureau was established with one fire inspector. Today the staff of seven uniformed and two civilian employees oversee 2,400 businesses, fire investigations, fire and emergency service impact fees, development and construction projects, and fire/life safety education

2014: South Adams County Fire Fighters Association was created to aid, and benefit injured or sick firefighters and their families, as well as to support active and retired firefighters of SACFD.









COVID RESPONSE

South Adams County Fire along with many surrounding fire departments are continuing to monitor COVID-19 we are taking precautionary measures.

03-16-2020:

Effective March 12, 2020 we canceled all fire prevention activities; inspections and community-based events including station tours, story time, car seat checks, crew visits and use of community rooms until further notice.

03-19-2020:

South Adams County Fire Department, Fire Chief Kevin Vincel signed a Declaration of a Local Disaster Emergency on March 19, 2020.

03-20-2020:

South Adams County Fire message from our Fire Chief Vincel and Board President Fairfield on COVID-19 and what our department is doing to taking precautions. Our crews will continue to respond and service our community and appreciate all your support!

We are excited to announce much needed capital projects at South Adams County Fire Department. These projects help with our strategic planning, response time and utilization of resources and providing training and equipment for our firefighters.

The growth in Commerce City remains in high speed, along with increased department needs and service calls. Below are some exciting things we have planned to keep up with the growth and continue to provide excellent service to our community!

- **Training Center**: Purchased an existing 4-acre site with 40,000 sq. of building space in Commerce City to enhance our training division. The building will provide a source of state-of-the-art indoor training, space for personnel, quartermaster, and Information Technology. Additionally, SCBA maintenance, reserve apparatus and fire prevention and investigation equipment and a workout facility are some of the plans.
- Expansion of Fleet/Maintenance Shop: To enhance our abilities to keep up with our every growing fleet and be sure the Apparatus; Fire Engines, Trucks, Ambulances, and fleet vehicles are all in tip top shape for response. The expansion will allow for additional bays that will handle indoor heavy equipment maintenance, office space, building maintenance shop and potential for hiring additional mechanics.
- **New Station 1:** This fire house is in the core city located on 69th and Hwy 85 and is currently our building maintenance shop. Due to the high demands of calls to the south and west of the district (Dog Track property and Suncor) we determined that remodeling would be the best financial decision. Station 1 will house; 4 Firefighters and Engine 21
