Treasurer Anderson made a motion to excuse Vice President Gillan. Secretary Machuga seconded the motion. The motion was passed unanimously by roll-call vote.

President Fairfield led those present in a Moment of Silence.

Public Comments: None.

#### Approval of Minutes:

Secretary Machuga made a motion to approve the minutes of the September 15, 2020 Board meeting minutes, as presented in the Board packet. Treasurer Anderson seconded the motion. The motion was passed unanimously by roll-call vote.





<u>Changes/Addition to the Agenda</u>: Chief Vincel requested and the Board approved adding to the agenda a discussion regarding the use of certain equipment owned by the District in relation to upcoming election.

#### Special Reports:

Chief Report on District Projects:

Chief of Support Koger gave a brief update on the HQ Parking Lot. The repair of the HQ Parking Lot is estimated to begin October 30, 2020.

Chief of Support Koger gave a brief update on the Maintenance Facility. The permit has been received and mobilization will begin during 2021.

Station 1 plans have been submitted and are being processed for approval by Commerce City; rezoning has been submitted and moving forward. Estimated completion of the project during 2021.

Rezoning at the Training Center has been completed and plans have been submitted to Commerce City for approval. Estimated completion during 2021.

Internet upgrade at all stations.

Station 6 construction is on hold until further notice.

Chief of Support Koger gave an update on the land adjacent to Station 7 and noted that the appraisal has been received to allow a fair market value offer to be made.

Chief Koger gave an update on the concrete cost replacement for Station 8 to be determined.

Chief Koger gave an update on the sprinkler systems status for all the Fire Stations.

Chief of Support Koger gave a brief Association update.

#### Northglenn Ambulance Report:

Melissa Wartman with Northglenn Ambulance gave a brief report on September call volumes and response times.

#### Board Action Items:

Treasurer Anderson made a motion to approve the Sick Leave Policy Amendment with inclusion of the Sick Day hours and other changes made necessary by recent changes in Colorado law that become effective January 1, 2021. Director Bullock seconded the motion. The motion was passed unanimously by roll-call vote.
