Board Action Items:

a. Volunteer Firefighter Gillan Retirement Approval. Chief Vincel reported that Volunteer Firefighter Gillan has met and completed all the training hours and service and has gone through the proper channels. All documentation is set and complete for Volunteer Firefighter Gillan to receive a 10-year pension. Mr. Gillan must refrain from the vote. Secretary Machuga made a motion to approve Volunteer Firefighter Sam Gillan's retirement. Treasurer Anderson seconded the motion. The motion was passed unanimously by roll-call vote.

Fire & Police Pension Association:

Chief Vincel gave a brief overview of the pension with FPPA. He reported that the fire department made the contribution at the end of 2020. The amount funded by the department was more than FPPA required due to the increase voted on by the board in 2020. FPPA does an actuarial study every two years advising the fire department how much to fund and the fire department has the option to lower or raise the amount. Chief Vincel closed by saying the fund is very sound.
